PRIVACY NOTICE

Privacy Overview

This is a summary of how we may collect, use and transmit information about you. It is a general overview only as there is a limited exemption within the GDPR for small and medium-sized organisations with fewer than 250 employees, whereby we u only need to document processing activities that:

are not occasional; or could result in a risk to the rights and freedoms of individuals; or involve the processing of special categories of data or criminal conviction and offence data.

How we collect information and what information we collect?

- When you provide it to us: we collect personally-identifiable information, including name, title, company, address, email address, phone numbers, etc. when you voluntarily provide it to us.
- When you use the website: our servers also collect the domain names of visitors to our site.
- Cookies: we may use cookies on our website.

How we may use your information

- To facilitate customer service or to enable us to contact you if you request information.
- Share and/or disclose information to other third parties as agreed by you, and for lawful purposes.

Do we share information

We may share the information you provide to related companies and individuals as part of our agreed discussions with you. We do not share your information with any other third parties.
